CCA recommends the Cincinnati Police Department strengthen its policies regarding interactions with people who are suspected to be physically or developmentally disabled and review existing policies to ensure the handling, detention, and transportation of such persons complies with the Americans with Disability Act (ADA). CPD Policy 12.110 outlines how officers should interact with "Suspected Mentally Ill Individuals," and Policy 18.103 outlines how officers should treat "People Who are Deaf or Hearing

Impaired;" a similar policy should be created regarding physically or developmentally disabled persons that specifies ADA-compliant standards for moving, detaining, or otherwise handling such persons. At a minimum, CPD should follow the example of the Columbus Police Division for the treatment of "Non-Ambulatory" prisoners, and (a) require its officers "to make reasonable accommodations to ensure their safety;" (b) require officers to transport such prisoners in a manner that "allows the prisoner to remain in his or her mobility device," such as a wheelchair; (c) mandate that officers must transport such disabled persons in an "ADA accessible vehicle;" and (d) require a supervisor to respond to the scene when "there is a question concerning whether a non-ambulatory prisoner needs to be transported by a medic or other ADA accessible vehicle." *See* Columbus PD Division Directive 3.03. CPD's new policy should also adopt the IACP's (International Association Chief of Police) guidance that "when reasonable and practical, avoid physical restrains," which can "injure the person or limit the person's ability to communicate," or limit the person's ability to "move independently (e.g., someone who uses a wheelchair)."

Mr. Jermaine Watson stated that he was on his way to his second shift job as a youth advocate for at risk youth when he stopped at a BP gas station on Hopple Street because his vehicle was low on engine oil. He pulled in front of the gas station store and lingered in his vehicle for about 3-4 minutes as he was watching a documentary on his phone. "From the time I pulled up to the gas station and watched the documentary I never spoke to anyone, waved to anyone, head nod or anything. So, I got out the car, walked inside of the store, I got my things, I came back outside. At this time, I still never spoke to anyone, said nothing to anyone or anything. I opened up the hood of my car and put the oil inside of the engine I closed the hood, still didn't speak to or said nothing to anyone, got back in my car, drove off headed to get my youth."

He further stated," [n]ext thing I know I see about 7-8 police officers behind me with their lights on but this time I'm thinking that something just happened on the other side like Westwood side of town, I thought they were just going past me. I see a Charger, like a dark gray Charger just get in front of me and it slowed down so I'm looking, and the police are still behind me so at that time I start slowing down. And I'm confused as to what's going on, so I put my hands on the steering wheel because I'm licensed to carry I had my gun in the car and I put my hands on the steering wheel and the police officers that were in the back of me they got out their car with their guns drawn."

COMPLAINT SUMMARY

Mr. Anthony Hogan alleged that on July 7, 2021, he visited the Kroger Store located at 4777 Kenard Avenue to address an issue with a previously issued money order. During the incident, Mr. Hogan operated an electric wheelchair owned by Kroger. A dispute transpired at the customer service counter and a Kroger manager ultimately called 911.

Mr. Hogan advised the officers he was disabled. He alleged he was dragged out of Kroger and put into a cruiser. Upon arriving at the Hamilton County Justice Center (HCJC), the officers laughed at his condition

and stated that he was "faking" and could walk. He also stated that his arms and wrists hurt because of the

way he was handcuffed. A nurse at the HCJC ultimately refused to accept Mr. Hogan and he was taken to his residence. Mr. Hogan asked for a supervisor but was not granted the opportunity to speak with one.

Officers should note that people experience physical or developmental disabilities on a spectrum; a person may appear to have a range of mobility, but still be disabled.

With respect to the use of force, if the physically or developmentally disabled person presents an immediate threat, the threat should be neutralized, and a supervisor should immediately be requested regardless of if force is used. If the person presents no physical threat, then consistent with IACP guidance (particularly for persons with developmental disabilities), the supervisor should be called before going hands on with said person. CPD policy should require supervisors to make the ultimate decision regarding next steps and transportation to the HCJC if it is determined necessary.

CPD policy on handling persons with disabilities should be reviewed for compliance with the Americans with Disability Act (ADA), Title II, which prohibits discrimination in the services of public entities. *See e.g.*, *The Americans with Disabilities Act (ADA) and On-the-Street Police Encounters*, published by the Congressional Research Service, 9/30/2021 (stating that "The courts have consistently held that police departments are 'public entities and that Title II applies to at least some state and local law enforcement functions.)

On April 6, 2021, at 11:00 PM, Ms. Bell believed that fumes were coming into her apartment via cracks in the walls and called the Emergency Communications Center (ECC) to request the Cincinnati Fire Department (CFD). The call was labeled as MHRT and CFD responded along with Cincinnati Police Officers (CPD), (later identified as Officers Mercado and Deon Mack Sr. #PO558, B/M/46), and Mobile Crisis Team 5 (MCT5). Officer Mercado transported Ms. Bell to the University Medical Center Psychiatric Emergency Services (PES), against her will. Ms. Bell believed this was an improper seizure of her person.

On January 1, 2022, at 9:30 AM, Ms. Bell called ECC to request transport to the University of Cincinnati

Medical Center (UCMC) after she believed that she was injured. Ms. Bell stated that she thought she had been kidnapped the night before and had a dent on her head. Officer Mercado and an unknown officer (later identified as Toni Nash #PO463, B/F/55), arrived on the scene to assist. CFD ambulance refused to transport her to UCMC after they evaluated her.

Furthermore, Officer Mercado entered the residence when she was not allowed.

Ms. Lewis alleged that on Wednesday, June 8, 2022, she contacted District Three to report two vehicles that were parked in the street in the 2500 block of Mustang Drive for an extended amount of time. Officer Minella responded and did not have the vehicle moved. In previous instances, Officer Minella placed "orange tags" on the vehicles. Ms. Lewis believed Officer Minella provided a lack of service because the vehicles were never towed. Ms. Lewis informed CCA that her neighbor, a female she believed to be named "Sandy," called the City of Cincinnati in November of 2021 about another abandoned vehicle owned by the same person, and the vehicle was towed the same day. Ms. Lewis stated she felt as if her neighbor received different results than her because Sandy is white, and Ms. Lewis is Black. Ms. Lewis stated to CCA she has tried to talk to Officer Minella's supervisor at District Three several times and no one will return her calls. Ms. Lewis called 591-6000 to report the same vehicles and was told by the customer service representative that Officer Minella "closed out" the call about the vehicles, and that they had been instructed by him not

to take any more complaints from Ms. Lewis. The vehicle Ms. Lewis called about is still currently parked in the same place.
