#R2203 - Courteous and Professional Behavior

CCA recommends CPD create one all-encompassing off-duty-conduct policy that regulates off-duty enforcement action, covers other off-duty incidents, and contains reporting requirements sufficient to trigger appropriate oversight in the event of such off-duty enforcement action or incidents. Such a policy should adopt elements found in those from other police departments, such as the Cambridge Police Department's "Off-Duty Police Powers & Conduct Policy" and the "Off-Duty Arrests" model policy proposed by the International Association of Chiefs of Police.

#R2204 - Corrective and Disciplinary

Given recurring violations of police policy by Police Officer Marc Schildmeyer during a consecutive multi-year period—including repeated improper enforcement activity that resulted in (3) Sustained findings from CCA for Improper Search in 2018 and 2019, as well as numerous Sustained findings in the present 2021 case for inappropriate off-duty enforcement action—CCA recommends that CPD review Officer Schildmeyer's performance, begin Supervisory Monitoring, and take all appropriate corrective or disciplinary action.

On June 6, 2019, Ms. Lakisha McMillan stated her son, Mr. Durrell Nichols, entered the Young Men's Christian Association (YMCA) on Montana Ave. and played basketball with an unidentified friend. YMCA Management contacted CPD. When Officers Douglas Utecht and Casey Carver arrived, they asked Mr. Nichols to leave. Mr. Nichols did not understand why he had to leave. CPD officers did not attempt to speak to Mr. Nichols or de-escalate the situation, but instead, Officer Utecht punched Mr. Nichols from behind and choked him. Mr. Nichols was unable to breathe and fought back. Officers Utecht, Carver, Andrew Snape, Joshua Wallet, and Jerome Herring, Jr. tased Mr. Nichols repeatedly. Mr. Nichols sustained injuries to his arms, stomach, and back from the TASER barbs. Officers arrested Mr. Nichols, failed to read Mr. Nichols his rights, and charged Mr. Nichols excessively.

On 07/29/20, Officer Nicholas Casch, arrived at Ms. Amber Wilson's, residence with a search warrant. Ms. Wilson was handcuffed and placed in a cruiser while he and additional officers searched her residence. The officers located several items, including speakers, liquor, money, and marijuana. When Ms. Wilson

reviewed the search warrant, she noted the officers did not find the items they claimed to be looking for (such as firearms or weapons). The officers arrested her son's father, Witness A, for an open warrant.

On 07/30/20, Officer Casch served Ms. Wilson with a Motion Nuisance Abatement. He explained that her residence had been seized and she must vacate her residence because it would be boarded up. Ms. Wilson called CPD to have access to her residence and obtain some belongings, Officer LaDon Laney, responded.

In June 2020, Officer Laney responded to a noise complaint regarding Ms. Wilson's home. Ms. Wilson explained the complaint was from a relative who wanted Ms. Wilson evicted. Later, she attempted to report telephone harassment, but CPD did not follow up regarding her complaint.

As a result of CPD's actions, Ms. Wilson and her minor children are homeless. Ms. Wilson noted CPD has not attempted to evict other families from their home despite criminal behavior.

On November 2, 2020, Mr. Antonio Huff drove along MLK then onto Jefferson Ave. and was followed by a marked CPD cruiser. After approximately one mile, the officers activated their sirens and claimed he made a marked lanes violation. When the officers approached the vehicle, they "grabbed" Mr. Huff out of the vehicle, placed him in handcuffs, and searched him locating crack. The officers "roughed him up," as they handcuffed him. He did not sustain any injuries.

Mr. Huff estimated there were at least 20 officers on the scene, both uniformed and in plainclothes. The officers searched Mr. Huff's vehicle without his consent. The officers used profanity and spoke "nasty" towards him, although he could not recall any specific remarks. Mr. Huff was charged with a marked lanes violation and possession of drugs and transported to the Hamilton County Justice Center (HCJC).

COMPLAINT SUMMARY

Mr. Baker alleged that on February 4, 2021, at approximately 8:00 PM, he observed Officers Mullis and Scalf looking through the window of his friend's rented vehicle. Mr. Baker exited the residence to inquire as to why the officers were looking at the vehicle. The officers explained that they saw marijuana in plain view in the cup holder of the vehicle. Mr. Baker explained that the vehicle was not rented in his name, but that the marijuana was his and that he would accept the citation. Mr. Baker was ultimately arrested for Ohio Revised Code (ORC) 2925.03 Trafficking in Drugs, his money seized, the vehicle towed, and his acquaintance' residence was searched.

Mr. Baker was released from the Hamilton County Justice Center (HCJC) after the laboratory determined that the substance Officers Mullis and Scalf recovered was not methamphetamine as believed. Mr. Baker alleged Officer Mullis was rude and did not return his belongings promptly after being dismissed from the HCJC.

On April 5, 2021, at approximately 11:45 PM, Officer Marc Schildmeyer (P.O. Schildmeyer) observed a minivan which he alleged moved at a fast rate of speed through a residential neighborhood. P.O. Schildmeyer was off-duty, in plain clothes, but armed with his duty weapon which was in his front right or left pant pocket. He pursued the vehicle and found it stopped at a stop sign at the intersection of Asbury Hills Drive and Asbury Road.

P.O. Schildmeyer parked diagonally in front of the van and approached the driver's side window. An argument ensued between three teenage occupants of the minivan, Witness A, B, and C and P.O. Schildmeyer who stated he was a police officer but did not show his badge nor any city-issued identification. Rather, he brandished his firearm. As the argument continued, P.O. Schildmeyer grabbed Witness A and held on to him by the shirt. All three occupants of the minivan exited the vehicle and P.O. Schildmeyer was struck in the head. Both parties eventually retreated, and the minivan fled the scene prior to the Hamilton County Sheriff's Office (HCSO) arriving on scene.

The complainant, Michael Kennedy, alleged P.O. Schildmeyer stopped Witnesses A, B, and C improperly, brandished his firearm unnecessarily, and refused to provide anything to verify that he was CPD.

RECOMMENDATIONS

Recommendation #R2203

Courteous and Professional Behavior

CCA recommends CPD create one all-encompassing off-duty-conduct policy that regulates off-duty enforcement action, covers other off-duty incidents, and contains reporting requirements sufficient to trigger appropriate oversight in the event of such off-duty enforcement action or incidents. Such a policy should adopt elements found in those from other police departments, such as the Cambridge Police Department's "Off-Duty Police Powers & Conduct Policy" and the "Off-Duty Arrests" model policy proposed by the International Association of Chiefs of Police.

Presently, some off-duty conduct is addressed by CPD Procedure § 12.205 Traffic Enforcement; § 12.555 Arrest/Citation: Processing of Adult Misdemeanor and Felony Offenders. Off-duty conduct is also addressed by the Manual of Rules and Regulations among other policies. These policies and procedures require off-duty officers to contact ECC to request a CPD supervisor who is prompted to initiate an investigation in the event of an off-duty "enforcement action." However, limiting those requirements to an "enforcement action" leaves many other critical scenarios unaddressed. As demonstrated by this case, the physical altercation in July 2020 may not be considered an enforcement action, but it resulted in an off-duty CPD officer striking a person, and it resulted in a law enforcement response, none of which was apparently required to be reported to CPD under current policy.

The creation of an all-encompassing off-duty conduct policy could close gaps in existing police policy by requiring officers to report all off-duty conduct where an officer asserts themselves as a police officer, in addition to other conduct bearing on an officer's fitness for service. For instance, even if no enforcement action is taken, such a policy should require officers to report all off-duty self-activations; all off-duty involvement in physical altercations; all off-duty incidents involving a response by outside law enforcement officers (in their professional capacity); domestic violence accusations against officers; and

any incidents where officers learn they are the subject of a criminal complaint or investigation.

Recommendation #R2204

Corrective and Disciplinary

Given recurring violations of police policy by Police Officer Marc Schildmeyer during a consecutive multi-year period—including repeated improper enforcement activity that resulted in (3) Sustained findings from CCA for Improper Search in 2018 and 2019, as well as numerous Sustained findings in the present 2021 case for inappropriate off-duty enforcement action—CCA recommends that CPD review Officer Schildmeyer's performance, begin Supervisory Monitoring, and take all appropriate corrective or disciplinary action.

Monitoring is particularly important given the similarities between the off-duty incident which is the subject of this report and the off-duty incident which took place in July 2020. CCA is concerned about Officer Schildmeyer's pattern of behavior and the resulting violence.
