#### **Public Comment**

Mrs. Iris Roley, Cincinnati Black United Front, commented on CCA #19007 – Mrs. Roley asked if the complainant involved in CCA #19007 was fine with the final investigation report being held to December 2021 as opposed to being heard at the November 2021, as scheduled. She also commented on complaints regarding tinted windows. Mrs. Roley believes CCA can problem solve around many of the issues regarding the allegations related to tinted vehicle windows in hopes of developing a better atmosphere between citizens and Cincinnati police.

Mr. Matthew Korte commented on the definition of harassment. Mr. Korte comments were also related to CCA's Recommendation #2122, which recommends CPD create a specific definition and policy for harassment in order to clarify the line between persistent contact initiated by police that is permissible and impermissible patterns of contact that either have no legitimate purpose are not tailored to a legitimate purpose or that otherwise violate policy. Mr. Korte asked about CPD's response the Recommendation #2122.
