

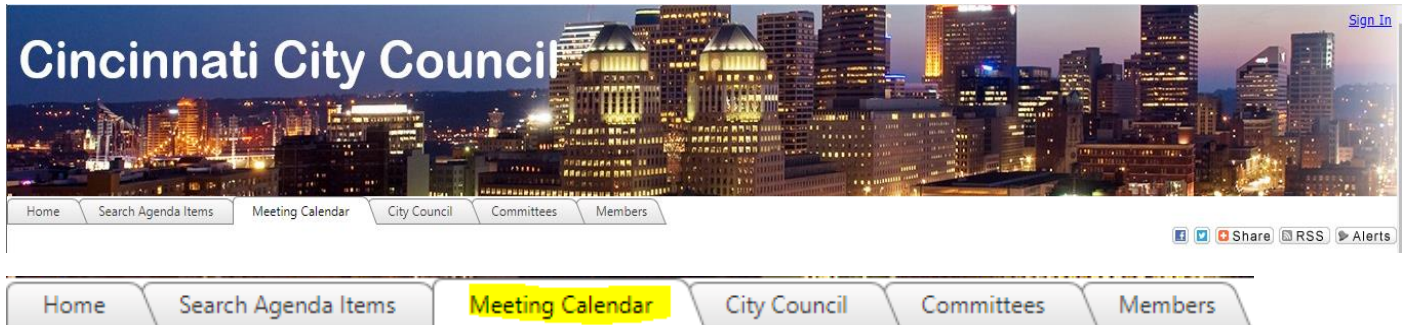
NEW online Council Legislative system

CINCINNATI – The City of Cincinnati is moving to a [NEW online Council Legislative system!](#) It will replace the current “Council Online”, to search Cincinnati City Council legislative items. The NEW website will also provide the ability to view upcoming City Council & Committee meetings and to view/download meeting agendas and minutes.

PHASE 1: Only new items received after June 2020 and items for upcoming meetings will be entered in the new system. Use the new system to search for new items and agendas for upcoming meetings. **The old system will need to be used to search for items prior to July 2020.**

PHASE 2: All items will be moved to the new system. The old system will be removed.



MEETINGS (Meeting Calendar Tab)

Click on the Meeting Calendar tab to browse City Council and Committee meetings in “List View” by a date range or in a monthly “Calendar View”. Each meeting listed contains the date, time, and the location; meeting details, including notices (such as Public Hearing, Special Meeting, Cancellation), agenda supplements, and list of all considered legislation; the agenda; the agenda packet; and the minutes.

NOTE: Live and recorded videos of the Council and Committee meetings will also be available here at a later date.

Click on a calendar icon to add a meeting from the calendar to your Outlook calendar.
