I. Roll Call

II. Approval of Minutes

The Minutes of the October 14, 2024 meeting were approved as written. Minutes are available at https://www.cincinnati-oh.gov/dote/lunken-airport/lunken-airport-boards/

III. Hotel Development Update

The development group resubmitted the plans to the Federal Aviation Administration (FAA) in October. The FAA gave approval with conditions including fine-tuning the boundaries of the lease areas. A list of terms was signed by the developer, but it has not yet been signed by the City Manager. There are more details to settle before a Lease Agreement will be prepared.

IV. Operations Report

Operations through November are 114,345. Total operations were down in November while Runway 3/21 was intermittently closed for the following improvements related to the closure of the former 3L/21R:

- Repainting of the centerline and edge lines
- Removal of the "R" and "L" designation from the pavement since the parallel runway no longer exists
- Replacement of signs to eliminate the "R" and "L" distinction
- The Airport took advantage of the closures to perform necessary crack sealing on both the runway and intersecting taxiway

The FAA paid 90% of the project costs, and the City contributed 10%. The City has applied for reimbursement from the Ohio Department of Transportation for 5%. The Airport paid for the crack sealing from available funds in its Capital Budget.

V. Financial Report

The Airport's Net Operating Income for Fiscal Year 2025 is \$192,916.00. Expenses were higher due to one-time charges for Workers' Compensation Insurance and General Fund Overhead. These expenditures were anticipated and were included in the Airport's budget.

City Council recently approved a new Lease Agreement with 39th Parallel Leasing, LLC that increased the rent and allows for further adjustments at the beginning of each renewal period.

VI. Customs Facility Update

The temporary Customs and Border Protection (CBP) facility at Procter & Gamble has processed 184 flights since January 2024.

The City is negotiating a month-to-month lease with a corporate tenant whose facility satisfies the CBP requirements for a permanent facility (office space, ramp space, etc.). A Request for

Proposals, including a scope of work, is being prepared to select a contractor to perform a site assessment.

VII. Strategic Business Plan

The Strategic Business Plan will take into consideration current and future expenditures. It will likely include a 5- to10-year forecast. A "Mission" and/or "Vision" Statement will be created, and stakeholder outreach, interviews, and feedback will be sought. The Board will have a role in the process.

VIII. New Business

Lunken's Airport Layout Plan (ALP) is now fully executed and signed by the FAA. The ALP is available on Lunken's page on the City's website:
