KNOW ALL MEN BY THESE PRESENT:

(\$1,000.00) for the payment of which well and truly to be made, we bind ourselves, our
executors, administrators, successors and assigns, jointly and separately and firmly by these
present.

The conditions of the above obligations are such that”

WHEREAS, Principal has been issued a certificate of competency pursuant to Section 401-33
of the code of Ordinances of the City of Cincinnati permitting him to extend, repair, and alter
water service branches 3/4 inch, 1 inch, 1 1/2 inch and 2 inch in size in subdivisions where the
water mains are under the jurisdiction of the Greater Cincinnati Water Works for a period of up
to (1) one year from _____
to **December 31, 20__**, inclusive; and

WHEREAS, Section 401-33 of the Code of Ordinances and the Greater Cincinnati Water
Works Rules and Regulations provide that before any certificate of competency is issued to any
person such person shall furnish to the Superintendent of the Greater Cincinnati a bond in the
sum of one thousand dollars (\$1,000.00) indemnifying the City of Cincinnati from any loss it
might suffer through the fault of the person to be certified, or his agents or employees, in
installing any water service branch or meter; therefore,

WHEREAS, Principal has been issued a certificate of competency permitting him to install
water service branches 3/4 inch, 1 inch, and/or 1 1/2 inch and 2 inch in size in subdivisions where
the water mains are under the jurisdiction of the Greater Cincinnati Water Works for a period of
up to (1) one year, from _____ to **December 31, 20__**, inclusive;
and;now, therefore

If Principal, including his agents and employees, performs all work for which a certificate of competency has been issued and the work and material used to conform to all Ordinances, Rules and Regulations of the Greater Cincinnati, Water Works, and shall, upon notification from the Superintendent of the Greater Cincinnati Water Works, repair or correct any defective work done or improper materials used on the Greater Cincinnati Water Works System, done or caused by him, his agents or employees, then this obligation shall be void. Otherwise, it shall remain in full force and effect: the undersigned agreeing and consenting that this undertaking shall be for the benefit of the City of Cincinnati and any other party sustaining any loss of reason of principal, his agents or employees, failure to use proper materials or correctly install water services branches and all appurtenances from the water main to the edge of the street right of way in accordance with Ordinances of the City of Cincinnati and Rules and Regulations of the Superintendent of the Greater Cincinnati Water Works during the period of his bond and that either he obliges herein or any such party of both may bring action on this bond.
