**BOND (CONTRACTOR)**

are hereby held and firmly bound unto the City of Cincinnati in the sum of Ten Thousand Dollars (\$10,000.00) for the payment of  
which will and truly to be made, we bind ourselves, our executors, administrators, successors and assigns, jointly and separately as  
follows:

The conditions of the above obligations are such that:

**WHEREAS**, the City of Cincinnati through its Director of the Water Works may permit the owner or owners of property to be  
served by water, to provide for the alteration of the public water main infrastructure by private contractors pursuant to Section 401-  
13 of the Cincinnati Municipal Code and other pertinent provisions of the Cincinnati Municipal Code, and

**WHEREAS**, Section 401-13 of the Cincinnati Municipal Code and Rule 5 of Section 401-13 of the Greater Cincinnati Water  
Works Laws, Ordinances, Rules and Regulations and other pertinent provisions of the Cincinnati Municipal Code provide that a  
private contractor employed to alter the public water main infrastructure for an owner or owners of property to be served by water,  
must furnish a bond in the amount of \$10,000.00 for each project, guaranteeing the proper installation, repair or replacement of  
such water main and appurtenances in accordance with the Water Works specifications to the satisfaction of the Director of Water  
Works, and

**WHEREAS**, Principal has been employed by \_\_\_\_\_, as owner or owners, to alter the  
public water main for the project known as \_\_\_\_\_; now, therefore,

**IF PRINCIPAL**, including Principal's contractors, agents and employees, performs all work in altering the public water  
infrastructure in accordance with the ordinances of the City of Cincinnati and the Rules and Regulations of the Cincinnati Water  
Works and shall, upon notification from the Director of Water Works, repair any defective work of which the City of Cincinnati is  
liable, caused by Principal, the Principal's agents or employees, then this obligation shall be void; otherwise it shall be and remain  
in full force and effect; the undersigned agreeing and consenting that this undertaking shall be for the benefit of the City of  
Cincinnati and any other party sustaining any loss by reason of the failure of Principal, Principal's agents or employees, to  
properly alter the public water infrastructure in accordance with the Rules and Regulations of the Director of Water Works during  
the period of this bond, and that either the obligee herein or any such party or both may bring action on this bond.
