**BOND**

**(TEMPORARY WATER USAGE)**

KNOW ALL MEN BY THESE PRESENTS:

That I/We \_\_\_\_\_  
as Principal and \_\_\_\_\_  
as Surety, are hereby held and firmly bound unto the City of Cincinnati in the sum indicated below and for the period of up to one year, for the payment of which well and truly to be made to the City of Cincinnati, we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, and firmly by these presents as follows:

The conditions of the above obligations are such that any person requesting the temporary use of water through a prescribed meter shall furnish to the Greater Cincinnati Water Works a bond indemnifying the City of Cincinnati from any loss it might suffer through fault of person or company requesting temporary water in the use of the meter, hydrant, direct connection to the water distribution system, or any water appurtenance associated with temporary water usage.

Principal, including principal's agents and employees, performs all work and agrees to remit payment for all costs associated with temporary water usage in accordance with the ordinances of the City of Cincinnati and the rules and regulations of the Greater Cincinnati Water Works. Such costs may include, but are not limited to permit fees for a maximum of three-month usage, jurisdictional fees, damaged or lost meter repair and

replacements costs, spanner wrench replacement costs, etc. The water meter and appurtenances must be returned on or before the expiration date of the permit in the same condition as when issued, less normal wear and tear and, upon notification by the Greater Cincinnati Water Works, repairs or corrects any defect or any damage done to the Greater Cincinnati Water Works System, or any other water system for the maintenance of which the City of Cincinnati is liable, caused by principal or principal's agents or employees, then this obligation shall be void, otherwise it shall be and remain in full force and effect; the undersigned agreeing and consenting that this undertaking shall be for the benefit of the City of Cincinnati and any other party sustaining any loss by reason of principal, or principal's agents, or employees.
